It is involved in R&D activities of National Importance. CSIR-National Metallurgical Laboratory has the largest creep testing facility in India and one of the largest in Asia. Its material evaluation and characterization facilities compare with the best in the world. CSIR-NML has strong presence in Magnetic materials, rapidly solidified alloys, surface Coatings. Metallic Foams, and many others.

This laboratory purchases instruments, equipments, machineries, spares, chemicals and consumables etc. from foreign based manufacturers located in various countries.
