UNLOCKING INDIA'S POTENTIAL

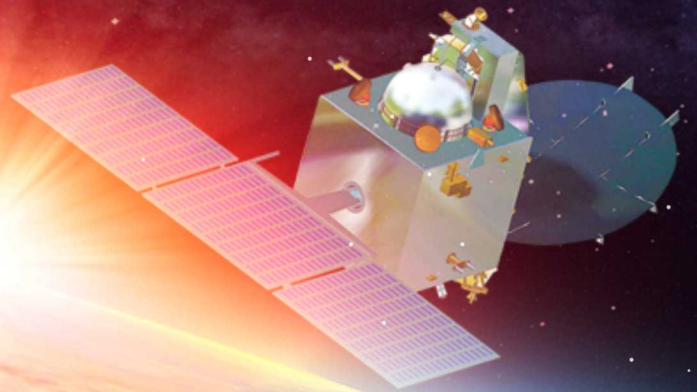
