### 11.0 Packing instructions

The super structures for MMS set components shall be packed in bundles with steel straps with corner wedges of plastic/fibre/rubber material to prevent damage to surface during handling. Adequate no. of steel straps shall be provided depending upon the length of the MMS components and bundles shall be in lots of 50 nos. /100 nos. for easy handling and accounting.

### 12.0 Marking Instructions

All Super structures for MMS Set shall be marked for part identification on 100% basis. Vendor to indicate the initial which he will mark along with the Technical specification to BHEL for approval as multiple vendors should not have same initial.

### 13.0 Delivery Schedule

- 1. Final drawing for Super structures for MMS will be issued with Purchase order and manufacturing to begin with this drawing.
- 2. Vendor to offer the prototype of 1-MMS Table within 10 days of BHEL providing the complete drawings.
- 3. Vendor to supply required nos. of Super structures for MMS for 2 nos. MMS tables as per supply BOM (Except structures for SMB and GI Earthing strips) of required grade (E350/E250) for prototype load test at site within 15 days of BHEL providing clearance of prototype table (dimensional), if required.
- 4. Vendor to complete all supplies within 8 weeks from issue of final fabrication drawing of Super structures for MMS by BHEL-EDN after successful prototype load test at site, if done, otherwise from date of clearance of prototype (Dimensional) at vendor's work.
- 5. In case the fabrication drawing is issued later than purchase order then the drawing issue date to be considered for delivery calculation.

### 14.0 Warranty

- 1. The supplied Super structures for MMS for Module mounting structures shall be warranted for a minimum period of 10 Years from the date of supply.
- 2. During the period of Warranty, the vendor shall remain liable to replace any defective parts, that becomes defective in the plant due to solely from faulty materials or workmanship, provided such defective parts are not repairable at site. After replacement the defective parts shall be returned to the vendor's works at the expense of the vendor's unless otherwise arranged.
- 3. If any defects not remedied within a reasonable time, BHEL may proceed to do work at the vendor's risk and cost, but without prejudice to other rights, which the BHEL may have against the vendor in respect of such defects.
